RESERVATION / PAYMENT / FLIGHT / TERMS & CONDITIONS

- 1.0 Reservation (All these information are vital for entry permit applications)
- 1.1 **Reservation must be made at least 2 weeks before arrival with the following information:**
 - 1.1a **Name as per passport, Passport Number, Nationality, Date of Birth, Gender and body weight**
 - 1.1b **ETA & ETD with flight numbers and Hotel accommodation in Kota Kinabalu for emergency contact**
- 2.0 Payment
 - 2.1 30% non-refundable deposit upon confirmation, balance payment 1 month before arrival.
 - 2.2 Payments are non-transferable. All bank charges to be borne by sender.
 - 2.3 Payment can be made via telegraphic transfer to the following :

- 3.0 Flight
 - 3.1 Layang Layang shall not be liable nor responsible for any changes in scheduled flights, or missed connections due to whatsoever reason. Hence, purchase travel insurance is necessary to avoid financial hassles.
 - 3.2 **All return connecting flight should be at least 4 hours upon arrival from Layang Layang.** The Airline Operator will only assist to reschedule return connecting flight via Malaysia Airlines or airline who are member of the IATA in lieu of clause 3.1
- 4.0 Cancellation
 - 4.1 Full cancellation charge for cancellation made less than 72 hours before arrival date.
 - 4.2 50% cancellation charge for cancellation made less than two weeks before arrival date.
 - 4.3 30% cancellation charge for cancellation made less than three weeks before arrival date.
 - 4.4 100% cancellation charge for flight fare made less than three weeks before arrival date.

 - a. **Kindly arrive at TERMINAL 1 for check in at least one & half (1 1/2) hours before flight departure time.**
 - b. There is no air ticket issued but verification is via passport or I/C of guest by our Operation Staff.
The boarding pass will be issued thereafter. Our Operation Staff will offer assistance for check-in.
 - d. Baggage allowance is 30kg per person inclusive of hand baggage. Excess baggage is chargeable by the Airline Operator at MYR 10.00 per kg per way which is payable at the Resort. Otherwise, storage rental is available at Airport Terminal 1.
