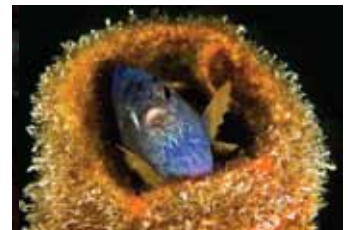
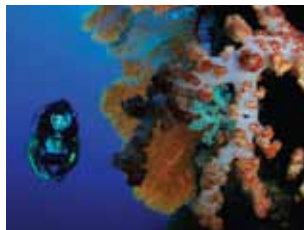

ENTRIES

1.0 All submissions must be on jpeg format with no less than 300 dpi.

2.0 All submissions must be taken with a digital camera during the trip 20-26 July 2011 at Layang Layang Island Resort (LLIR).

Notification

1.0 Winning entries will be unveiled at the resort and published in all major dive magazines.

TERMS AND CONDITIONS

1.0 LLIR U/W Digital Photo Shoot 2011 is organized by Layang Layang Island Resort.(LLIR)
